("Methods for testing papers and boards for food packaging", state of 2008, corresponding to the method no. 80.56 within the Official Collection of Test Methods according to § 64 of the Foodstuffs and Animal Feed Code - LFGB),

for the used raw materials, fabrication additives and special paper finishing agents as well as for the release of substances which might endanger health.

Moreover, the release of metals was examined according to the

DIN EN 71, part 3 "Safety of Toys, Migration of Certain Elements", state of August 2019,

and analyses for organic chemical compounds not approved for paper according to the

DIN EN 71, part 11 "Safety of Toys, Organic chemical compounds – Methods of analysis", state of January 2006,

were performed.

The paper grades are in compliance with the rules of the

Regulation (EC) No 1935/2004 of the European Parliament and of the Council of 27 October 2004 on materials and articles intended to come into contact with food and repealing Directives 80/590/EEC and 89/109/EEC, Official Journal of the European Union L 338/4 of 13.11.2004, modified by app. no. 5.17 of the regulation (EC) No 596/2009 of 18 June 2009, Official Journal of the European Union L 188 of 18 July 2009, article 3,

as well as of the

In addition they meet the demands of the

regarding their release of metals.

Furthermore, the requirements on the absence of organic chemical compounds in paper according to the

DIN EN 71, part 9 "Safety of Toys, Organic chemical compounds – Requirements", state of September 2007,

are met by the paper grades.

Thus, the paper grades **Norcote Bruck**, **Norcote Super**, **Norcote Top**, **Norcote Trend**, **Norcote Silk** and **Norcote Satin** according to the sample material submitted may be used safely for food packaging. They may stand in direct contact with dry and fatty foodstuffs.
